POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 30 SEPTEMBER 2021

The Board wishes to announce that all the Resolutions set out in the AGM Notice were duly passed by way of poll by the Shareholders at the AGM held on 30 September 2021.

Reference is made to the circular (the “**AGM Circular**”) and the notice (the “**AGM Notice**”) both dated 31 August 2021 regarding the annual general meeting (the “**AGM**”) of Ban Loong Holdings Limited (the “**Company**”). Unless the context otherwise requires, capitalized terms used herein shall have the same meanings as those defined in the AGM Circular and AGM Notice.

POLL RESULTS OF THE AGM

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to announce that all proposed resolutions set out in the AGM Notice (the “**Resolutions**”) were duly passed by way of poll by the Shareholders as ordinary resolutions at the AGM held on 30 September 2021.

As at the date of AGM, the total number of the issued shares of the Company was 6,448,152,160, which was the total number of Shares entitling the Shareholders to attend and vote for or against the Resolutions at the AGM. There were no restrictions on any Shareholders to cast votes on any of the Resolutions at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of the Resolutions at the AGM as set out in Rule 13.40 of the Listing Rules. There were no Shareholders who are required under the Listing Rules to abstain from voting at the AGM.

The Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.
